







DIMENSIONS

INSTALLATION INSTRUCTIONS FOR ADDRESSABLE CONTROLLER

MOUNTING: Choose the mounting location. When choosing mounting location keep the following in mind:

- Choose a location to minimize the possibility of being bumped into and a location away from excessive heat sources.
- Plan the routing of the wires to the power source, light strip(s), and control switch.

The Vista Addressable Module can be mounted using the recommended hardware listed in the chart below, depending on the material it is mounted to.

MATERIAL MOUNTED TO	RECOMMENDED FASTENER
Wood	#6 wood screw, round or pan head
Aluminum	#6 sheet metal screw, (optional self-tapping, self-drilling) OR #6 machine screw with mating nut
Fiberglass	#6 machine screw with mating nut and washer

WIRING: The Vista Addressable Module requires two to three different types of wiring connections. The wire connections can be made using solder and heat shrink, insulation-displacement connectors, wire nuts, or crimp splices. For most applications additional wire will be required between the devices being connected. When adding additional wire, ensure the wire meets the minimum wire gage mentioned for each type of connection below.

The Vista Addressable Module is powered from a 12-volt DC source. For automotive and marine applications, it can be connected to a 12-volt circuit that is protected by a 10-amp fuse. For building applications, a class 2, 12-volt power supply must be used. See power supply instructions for its mounting and connection to the building mains. The Vista Addressable Module's red wire connects to the supply's positive terminal and the black wire connects to the supply's negative terminal. Use AWG 18 or larger for these connections.

The Vista Addressable Module can be connected to one or two compatible addressable light strips using the sets of black, orange, and yellow wires. The two strips will display the same light sequence and should be the same length. Either one of the black wires connects to the light strip's negative supply input. Either one of the orange wires connects to the light strip's 5-volt supply input. Either one of the yellow wires connects to the light strip's data input. Use AWG 18 or larger for these connections. If only one light strip is connected, insulate the unused black, orange, and yellow wires with heat shrink, electrical tape, or other insulators.

The Vista Addressable Module must be connected to a control switch that will allow the user to select the preprogrammed light sequences. A single-pole, double-throw, center-off, momentary switch is recommended. Alternately, two momentary pushbuttons can be used. Use AWG 18 or larger for these connections.


For a double-throw switch, connect the white wire to the switch's common terminal. Connect the black / white wire to the switch contact relating to the up, or forward, contact. Connect the blue wire to the switch contact relating to the down, or reverse, contact.


For momentary pushbuttons, connect the white wire to one contact on each button. Connect the black / white wire to the remaining contact on the up, or forward, button. Connect the blue wire to the remaining contact on the down, or reverse, button.

SET UP: Light Strip Length Detection and Programming:

The Addressable Controller can be connected to light strips of any length. Some of the preprogrammed light sequences require the controller to know the length of the light strip to function properly. The Addressable Controller has a learning mode to detect the length of the attached strip and program it into the Controller. The following procedure should be performed when the controller is installed or any time the strip length is changed.





OPERATION: The use of the switch inputs requires the connection of a user supplied switch or buttons as shown in the Wiring section of these instructions. When the switch is properly connected, the user can cycle through the predefined light sequences listed below. Each press and release of the "UP" or "FORWARD" switch advances to the next light sequence. Each press and release of the "DOWN" or "REVERSE" switch selects the previous light sequence.

Selectable Light Sequences:

- 0 OFF
- 1 One Color Fade: All LEDs in strip change at the same time fading from one color to the next
- **2 Eraser**: Traveling White bar (eraser) on solid color background. At the start of the sequence, the white bar moves down the strip, and the current color of the LEDs change to another color. The white bar returns to the beginning once falling off the end, and each time, the color of the strip changes to another color as the white bar passes over them.

- 3 Multi Color Chase: Six LEDs are on, and they change colors while traveling down the strip. The sequence cycles back to beginning after falling off the end of the strip.
- 4 RGB Tail Chase: Red, Green, and Blue tails chase, one after the other, with space in between down the strip and cycle back to the beginning after falling off the end.
- **5 Rainbow**: Also known as circus, cycles through multiple colors, chasing back toward the beginning of the strip, all LEDs on the strip powered on and cycle continuously.
- **6 Opposite Rings**: A white tail starts at one end, and a blue tail starts at the other end. Once each tail reaches the opposite end of the strip, they bounce back the other direction and switch colors when they bounce off the ends of the strip.
- 7 Two-tone Chase: Four blue with three red LEDs chase down the strip and cycle back to the beginning after falling off the end.

MAXIMUM LIABILITY: Vista's liability to repair or replace a damaged item shall be limited to original purchaser of the item at the original purchase price of the damaged unit for two years from date of purchase. All liability of Vista shall be limited to and fully discharged by repair or replacement of such defective items without charge. In no event, whatsoever shall Vista be liable for incidental or consequential damages, including without limitation, removal or reinstallation costs, personal injury or property damages. Vista's liability shall not exceed Vista's invoiced price for the product on any claim arising from its use.

INSPECTION: Vista reserves the right to review the damaged item and the site where the damage occurred. Vista may require the purchaser to ship the items to Vista for inspection and the cost of such shipping shall be borne solely by the purchaser. The damaged item must remain available for inspection until the claim is finalized.

EVENTS THAT VOID WARRANTY: All above warranties are null and void if any or more of the following event occur;(a) the item is not provided to Vista for inspection upon Vista's request; (b) Vista determines that the item has been improperly installed, altered in any way or tampered with; and/or (c) Vista determines that the item was not used under normal operating conditions or in accordance with label or instructions for the item. In addition to the foregoing, this Warranty does not protect against damage to the item when Vista determines, in its sole discretion, that the damage resulted from acts of God such as lightning, flood, earthquake, war, vandalism, theft, normal-use wear and tear, corrosion, abuse, non-authorized program or system equipment modification or alteration.

DAMAGED GOODS: If you received damaged product from UPS or Common Carrier, please do not return product to Vista. Contact the shipper to initiate a claim.
